Until November 2018, he held the positions of partner and head of the Tax Group within Gowling WLG in Paris, where he advised global groups, leading SMEs and family-run middle-market companies active in various sectors, including modern technology, pharmaceuticals, music publishing, media, distribution and agri-food.

Julien MONSENEGO advises French and foreign companies on their national and international investments, strategic decisions and dayto-day operations. The PACTE Act, which has been presented as a revolution enabling or facilitating business growth and management, was finally adopted on 11 April following lengthy discussions.

Beyond a few interesting simplifications and other cosmetic changes, there are essentially two main thrusts.

Firstly, the very definition of a commercial company now includes the need to consider «the social and environmental impacts of its business»; a vague concept that will surely lead to difficulties of interpretation and disputes, including in the courts, in the event of talks with shareholders or even the relevant partners. But companies can also, voluntarily this time and instigated by their shareholders or partners, decide to expand their objects with a «corporate purpose, reflecting the company's guiding principles, to which it intends to allocate resources in the conduct of its business.» Therefore, nothing now stops a company, but on a voluntary basis, shifting its primary focus to a longer-term pursuit of wider interests by becoming an «entreprise à mission», and so moving beyond solely capitalistic profitmaking aims without undermining its own interests and value.

Secondly, and in the same spirit, there is now the possibility to sustain and protect the business in the framework of a «fonds de pérennité», to which all or most of the company's securities can be donated or bequeathed (for tax purposes and with the benefits of the «Pacte Dutreil»). Therefore, the «fonds de pérennité» safeguards the company over the long term whilst making it possible to finance one or more public-interest projects, following the model of shareholder foundations that have been tried and tested in some countries, particularly Northern Europe. Similarly, it is now easier for a public-interest foundation to receive, free of charge, and manage the majority of a commercial company's securities.

These interesting avenues show, as we have long known within DELSOL Avocats's various departments, that companies' profitability is not necessarily incompatible with public interest, or in any case can effectively cohabit with nonprofit organizations.

This controlled growth aims to cover a wide range of commercial law issues, making it possible to support economic and social stakeholders at all levels of risk, over the short, medium and long terms, and on their French and international operations. That is why the longstanding work on nonprofit organizations and social entrepreneurship has expanded significantly and several other departments have been formed, such as

"Life Sciences" in 2013 and "Personal Data" in 2017.

Considering its dual location as a distinguishing feature on the market, DELSOL Avocats is not neglecting its international presence. The Italian desk was launched to stimulate the firm's international development, with strong involvement in two global networks (TELFA and PARLEX) raising its profile whilst providing an opportunity to build ties with «best friend» foreign firms.

Alongside this exponential growth, DELSOL Avocats draws its strength from its system of governance. The Board, an effective management body, comprises five partners and meets weekly to review the various matters on the agenda: human resources, IT, communication, financing, investment, etc. It was chaired by Jean-Philippe DELSOL from 2003 to 2011 and Amaury NARDONE from 2011 to 2019, with **Xavier** DELSOL recently taking over.

Although a dedicated department was only launched in 2018, communication has always been seen as a strategic area, and as early as 2004 Amaury NARDONE took steps to

gained due recognition for its reputation. Amongst many other projects over the years, the firm has acquired presentation brochures, the De La Relation newsletter has been launched, DELSOL Avocats has featured on the airwaves of Radio Classique and the website has been modernized.
