#### Media

#### Analysis by Emmanuel KAEPPELIN & Philippe MALIKIAN:

The transport sector and the logistics sector (which encompasses activities as diverse as parcels delivery, logistics in the strict sense or Customs clearance) are undergoing massive changes and we are seeing a renewal of M&A activity in these sectors, both of which are highly regulated, not just because of the DREAL regulations, but also due to the specific characteristics of transport rules (CMR note, Gayssot Act, etc.).

The trend is towards consolidation, as much for corporate operators needing to bolster their positioning to contend with their competitors as for investors, who see this still fragmented sector as offering build-up opportunities.

Growing environmental awareness is also driving changes in modes of transport. It is against this background that DELSOL Avocats assists sector operators with their deals, litigation and contractual or employment issues both in France and beyond.

## **Hotel industry**

#### Analysis by Benoît BOUSSIER:

The hotel sector represents a very specific asset class that presents issues on many fronts: real estate, even when the premises are not owned; employment, because this is a service industry; and tax, since this is one of the few assets that combines real estate ownership with running a business.

Acquisition of hotel assets calls for special vigilance and detailed due diligence. Operating or leasing out a hotel are also complex operations in view of the contracts that sector operators have introduced, ranging from management contracts to commercial leases.

Interview with Arthur JAEGER, Director Development France at Cycas Hospitality: "Seeking advice from lawyers with specialist knowledge of the hotel industry and its codes is essential, because detailed knowledge of this particular asset class not only affords added security but also saves time when it comes to drawing up the contract. In my experience, a specialist lawyer will spot the issues and risks of a project from the very outset. By virtue of its very nature, a unique mix of real estate ownership and business, the hotel industry is a mine of potential pitfalls that detailed knowledge can help you avoid. As I see it, bringing specialists on board gives you an extra level of security, not to mention effectiveness in negotiating the contract, that it would be a shame to miss out on!"

Interview with Nicolas POTEL, General Counsel, France & West Mediterranean Region:

What legal issues do you see as inherent in your sector of activity? Given the diversity of 3M's activities in France, with basically two main types of client, distributors and end

customers, the Legal Department is confronted with numerous issues, mainly relating to contract law, distribution and competition. We also handle questions of intellectual property, data protection and employment law. In addition, we may have to deal with litigation arising from our activities, particularly product quality litigation.

We recently advised on deals involving both acquisitions and disposals of wine-growing estates in Burgundy, Bordeaux and the Loire and Rhône valleys.

This is a sector unlike any other in its practices and the issues it faces. It requires a sound grasp of the rules relating to the pre-emptive purchase rights vested in rural development agency Safer, and of the so-called "farming structures control" mechanism. Over and above these issues, particular vigilance is required as to the duration (particularly long-running) of rural leases, and the examination of wine-growing brands given the multiple layers of regulation (AOC, labelling, etc.).
