### The Olympic and Paralympic Games, both opportunity and challenge

On 13 September 2017, the International Olympic Committee chose Paris's bid to host the Olympic and Paralympic Games from 26 July to 8 September 2024. It will be the third time that the city has welcomed the Olympics after the 1900 and 1924 Games.

Organizing the world's biggest sports event is both an opportunity and challenge that presents a number of tests, whether in terms of infrastructure and accessibility, security, the environment, budget or national pride.

# Paris 2024: What effects on business deali

### Communicating during Paris 2024 Ambush marketing: the limits not to be crossed

As Paris 2024 approaches, many businesses are being tempted to run ambush marketing campaigns that involve associating their image with the Games without being official partners. It is a high-risk strategy.

### Protecting the terms and symbols associated with the Games

Olympic terms and symbols are the property of the International Olympic Committee (IOC). That includes not only the Olympic symbol (five rings), but also the Games' emblem, mascots, pictograms and terms such as "*Olympics*", "*Olympic Games*", "*Olympiad*" and the name of the host city ("*Paris 2024*"). Any companies using Olympic terms and symbols in their communications without the permission of the IOC or its exclusive licensees are leaving themselves open to legal action for fraud and unfair competition. "*Olympic pricing*" campaigns, sales messaging on social media with the hashtags #olympicgames and #paris2024, or promotional codes and competitions referring to the Games are just some of the marketing operations regularly punished by the courts. Precautions for communicating on the Games

Copying Olympic terms and symbols or distributing marketing messages that create uncertainty over the brand's involvement in the organization of the Games should be avoided.

Communications around the Games must be purely informative or topical, limited to a brief presentation of the facts (giving the schedule of sports meetings, sharing results, etc.) with no ambiguity over official sponsor status.

### Data sharing between health regulatory bodies and the OCOG\*

The involvement of massage– physiotherapists and pharmacists in Paris 2024

As healthcare professionals specializing in sport and exercise medicine, massage—physiotherapists have been asked to volunteer for the 2024 Games and support the athletes throughout the event. A temporary health centre will be created within the Olympic village for the duration of the 2024 Games and will include a pharmacy. For that reason, pharmacists are also being asked to volunteer.

### Reaching an agreement with the regulatory bodies

The OCOG has therefore entered into a data exchange agreement with the Massage—Physiotherapy Council and Pharmaceutical Council, giving the OCOG access to the registration status of professionals who have volunteered for Paris 2024. Concretely, its provisions stipulate that the OCOG provide the list of candidates and that the regulatory bodies confirm the legal practice requirements. Data is shared in compliance with the applicable data

### The Olympic Games and arbitration Emergency arbitration mechanisms

As for previous Games, the International Council of Arbitration for Sport (ICAS) has created an ad hoc division of the Court of Arbitration for Sport for Paris 2024, tasked with resolving disputes that may arise during the Games. The court comprises a dozen arbitrators appointed by ICAS. The court's jurisdiction is strictly limited to disputes that occur in the period between ten days before the opening ceremony and the closing ceremony. Access to the *ad hoc* court is only open after all internal remedies have been exhausted.

#### **Examples of rulings**

The court's rulings can cover an athlete's suspension, a national sports federation's selections or an Olympic Committee decision affecting participants. However, only in wholly exceptional circumstances will the court interfere in the field of play decisions taken by umpires and referees.

### The need to meet legal practice requirements

Although they will serve as "volunteers" in the 2024 Games, the massage—physiotherapists and pharmacists must be fully registered with their professional body to work with the athletes. For that reason, the OCOG must be able to check that candidates meet the legal practice requirements outlined in France's Public Health Code.

#### Speedy proceedings

Rapidity and urgency are the most characteristic features of the court. Applications can be submitted at any time in French, English or Spanish and decisions will be released within 24 hours of their proper filing. In the most urgent cases, the court can order temporary measures, such as allowing an athlete to take part in the Games despite a positive drug test. The speed is such that an eminent specialist has described proceedings as "*rock and roll*".

## Athletes' image rights The tax aspects of sponsorship agreements

Ahead of the Olympic Games, athletes representing sports with varying degrees of popularity may earn a significant proportion of their income by using their image to endorse a business and its brands.

#### The complex tax qualification of income derived from athlete endorsements

Unfortunately, French lawmakers have not created a specific tax and social security scheme for the income generated by athlete endorsements. The first question that then arises is whether such income should be seen as a salary (subject to national insurance contributions) or a fee (subject to income tax in the non-commercial profits – BNC – category and to social security contributions of 17.2%). Whilst in principle athlete endorsements generate income taxed in the BNC category, sponsorship agreements can be recategorized as modelling contracts, which has significant fiscal and social effects.

# The risk of recategorizing sponsorship agreements as modelling contracts

The Labour Code defines modelling services as: "any person who, even occasionally, presents to the public, directly or indirectly via reproduction of his/her image on any visual or audiovisual medium, a product, service or advertising message; or poses as a model, with or without the subsequent use of his/her image." Modelling contracts are presumed to be contracts of employment with remuneration subject to the fiscal and social rules on paid labour. Therefore, case law tends to outline the services that may come under the scope of modelling on one hand and sponsorship agreements on the other. As such, a kit manufacturer contract should be treated as a salary for the athlete (Speedo Order of 23 June 2022, number 21.10.416).

In any event, a case-bycase analysis is necessary to ensure the correct tax treatment of sponsoring top athletes.

Alexis BECQUART: What impacts are the Paris 2024 Olympic Games having on your federation?

**Basile LENOIR:** Beyond the selection of French athletes under the umbrella of the international federation, our federation has the privilege of hosting the 2024 Olympic Games' golfing event at Le Golf National in Yvelines. Le Golf National is our federation's hub, like Roland-Garros for tennis, Marcoussis for rugby and Clairefontaine for football. Le Golf National was built in 1991 with the aim of hosting the world's biggest

Sports federations, formed as governing bodies, administer their sport and manage their practice. They operate with complete independence in the framework of a government delegation or accreditation. They are at the grassroots of French sport and are stakeholders in the Paris 2024 Olympic Games.

golf events: the annual French Open, the World Team Championships in 1994 and 2022, and the Ryder Cup in 2018. So it's the culmination of over thirty years of federation strategy. manage the logistical delivery of the event at Le Golf National itself with some of our dedicated teams and more than 500 volunteers. The principle is to deliver the competition at cost price with fixed remuneration and a variable component maximizing savings under the Paris 2024 Organizing Committee's control. A.B.: How do you anticipate the Olympic legacy?

**B.L.:** The Government has asked us to put a programme in place to anticipate a potential influx of new players after the Games. We're already benefiting from the 100 small structures plan created with the same objective after the 2018 Ryder Cup. With our 750 member clubs, our digital tools are ready to manage any exceptional demand triggered by a podium finish and medal from our four French athletes (two men and two women).



A.B.: What measures have you taken as a result?

B.L.: We've created a consortium including the International Golf Federation and the four professional Tours (American and European, female and male) to meet OCOG specifications for staging the sports events. We were selected by the OCOG, which will Alexis BECQUART Partner
